In addition, housing inequality in modern times adds another layer to social injustice. Differences in affordable housing acquisition, quality, social isolation, and conditions contribute to this issue, primarily driven by socio-economic Low-income individuals and marginalised status. communities often face significant housing challenges. For instance, in Sham Shui Po, Hong Kong, many low-income families endure long waits for public housing, resulting in cramped living spaces. Basic sanitary facilities are often leading to poor living conditions. lacking, These circumstances highlight the reality of housing inequality.

Some of my relatives and friends reside in Sham Shui Po and confront these housing disparities, evoking deep dissatisfaction and sympathy.

From this book, we can better understand the effects of social inequality. Although the story took place centuries ago, many of these social problems such as wealth gap and social injustice still persist today. Readers can relate the real world to novel's plot, enhancing their understanding of the challenges in improving social injustice. It also reminds us that a person's efforts may not be sufficient to change the situation. However, this book also inspires us to strive for personal development and growth. In this way, we can have the ability and power to protect the people we care about and avoid becoming the most vulnerable people in society.

In order to prepare us in face of the upcoming challenges, we must equip ourselves effectively. Firstly, education and the pursuit of knowledge are essential. Studying provides us with a strong foundation of knowledge and equips us with necessary skills. Seeking diverse experiences and learning opportunities is beneficial to our personal growth.
